

Dear President Tusk,
Dear President Juncker,
Dear First Vice-President Timmermans,

The far-right continues to spread and entrench itself in the Member States. Authoritarian populists are able to exploit the fears of Europeans and convince the public to reject the very values that protect them. Without stronger grassroots support for the rule of law, democracy and fundamental rights among the European public, the EU's liberal democracies will progressively vote themselves out of existence.

Non-governmental organisations (NGOs) promoting and protecting the rule of law, democratic pluralism and fundamental rights play a vital role in sustaining open democracies. Just as an independent judiciary and a free press, they are key to ensuring healthy democratic participation and government accountability before the law and the electorate. In recognition of this fact, the European Parliament called on the Commission to create a 'European Values Instrument' in a resolution of 19th April.

The Commission has chosen to ignore the views of the EU's only directly elected institution. Despite promising rhetoric from the Commission, the proposal for a Rights and Values programme published on 30th May effectively constitutes a continuation of existing funding programmes. This is inadequate for four reasons. First, the proposal fails to support the kinds of activities that organisations need to carry out to promote and protect fundamental values. Second, the proposal is excessively narrow in scope, being limited to pieces of EU law and policy or action at transnational or Union level. Third, the proposal makes no allowance for a more flexible interpretation of the Financial Regulation, which has been interpreted narrowly to date so as to effectively exclude grassroots organisations. Fourth, the proposal opens the fund to a large range of beneficiaries including in third countries and falls far short of the sum the EU dedicates to supporting organisations promoting Article 2 values in third countries.

The EU can no longer rely on philanthropic foundations and the Norwegian government to fund support for its fundamental values. We call on the Commission to work closely with the Council and the European Parliament to facilitate the amendment of the proposal for a Rights and Values programme along the lines already called for by the European Parliament resolution on the European Values Instrument. In particular: the scope of the Rights and Values programme should cover Article 2 values in the round; the supported activities should correspond to those needed to promote and protect EU values; operational funding should be available to national level NGOs and not only European networks; a substantial minimum budget should be ringfenced for NGOs; the Commission should implement the Financial Regulation flexibly to make the fund accessible to national level and grassroots NGOs, including through the use of independent intermediary organisations that can regrant to smaller organisations.
